### Rotary International District 3502

Develop international goodwill and friendships by combining pre-professional caliber international musicians with young musicians in Taiwan in a summer program of rehearsals, performances, social activities and tours of Taiwan area attractions.

The camp will let young people from all over the world understand music, language and culture of Taiwan and establish international friendship with Taiwanese teenagers through two weeks of rehearsal and performance in the summer.

Camp: TAIWAN MUSIC CAMP

Period: 10 August - 26 August 2019

Location: Taoyuan, Taiwan and surrounding communities

Age & Gender: Males and females 16 - 24 years of age (Born between 1995-2003)

Participants: 30 international participants and 30 members of local high school/colledge Orchestra More than one representative per country can be accepted. (See Appendix for number of individual instruments that can be selected.)

Language: English.

Program: Participants will attend two weeks of rehearsals, culture and languages program. Rehearsals and music classes directed by 姜智譯 Roger Chih-I Chiang. At the end will perform in a public classical music performances as the Rotary District D3502 International Youth Symphony in Taoyuan Arts Center.

They will visit Taoyuan/Taipei area. There will be recreation with excursions, beaches in northern Taiwan, etc.

- Cost: Participants will have to pay a registration fee of USD\$650 after acceptance and travel costs to and from Taiwan. They also should bring adequate pocket money. All other costs will be covered by the host district.
- Insurance: All participants must be insured against illness, accident and third party damages according to Rotary International recommendations.
- Clothing: Casual and formal. You need sports clothes and walking shoes. In the concert you' II need white top & black bottom (See Appendex for dress code)
- Registration: See Appendix for number of individual instruments that can be selected. Every effort will be made to include applicants from unrepresented countries if the required level of ability is met.





Arrival: Taiwan Taoyuan International Airport on 10 August 2019 (participants will be picked up by camp officers)

Accommodations: Participants from abord will stay with Rotary District 3502 certified families.

# **AUDITION REQUIREMENTS**

- ALL RECORDINGS AND PERSONAL INFORMATION (PAGE 3 & 4 OF THE STEP APPLICATION) MUST BE RECEIVED NO LATER THAN 21 December 2018.
- Violin: (1) 3 octave F major scale, and 3 octave F# natural Minor scale ascending and descending, quarter note=80m.m. Separate bows with vibrato.
  - (2) One movement from one of the following concerti for violin: Barber, Beethoven, Brahms, Glazunov, Lalo, Mendelssohn, Paganini, Sibelius, Tchaikovsky, OR two contrasting movements from Bach sonatas and Partitas for violin solo
- Viola: (1) 3 octave A major and A natural minor scales ascending and descending quarter note =80m.m. Separate bows with vibrato.
  - (2) One movement from one of the following concerti for viola: Stamitz, Handel, Walton, J.C. Bach (transcribed from cello), Bartok OR two contrasting movements from the Bach cello suites transcribed for viola.
- Cello: (1) 3 octave A major and A minor scales ascending and descending quarter note=80 m.m. S eparate bows with vibrato.
  - (2)One movement from the following concerti for cello: Dvořák, Elgar, Haydn, Kabalevsky, Popper, Saint Saens, Tchaikovsky (variations), OR two contrasting movements from the Bach cello suites.
- Bass: (1) 2 octave A major and A natural minor scales ascending and descending quarter note=80 m.m. Separate bows with vibrato.
  - (2) A movement from one of the following concerti: Cappuzzi, Dragonetti, Koussevitzky or a similar work for double bass.
- Flute: (1) 3 octave chromatic scale from low B (with B foot key) ascending and descending mm=144 for quarter note. 3 octave C# natural minor scale mm=80 for quarter note with vibrato.
  - (2) A movement of a major concerto or concert piece for flute.
- Oboe:(1)2 octave chromatic from beginning on low C mm=144 for quarter note. 2 octave F major and F Natural minor scales mm=80 for quarter note with vibrato.
  - (2)One movement of a major concerto or concert piece for oboe (1) 3 octave A major and A natural minor scales (written) mm=80 for quarter note.
- Clarinet: (1) 3 octave A major and A natural minor scales (written) mm=80 for quarter note.
   (2) One movement of the Mozart Clarinet concerto or a concert piece for clarinet Must be fluent in all transpositions for clarinet. Use of A clarinet may be required.
- Bassoon: (1) 3 octave D major and D natural minor scales mm=80 for quarter note with vibrato. (2) A movement of the Mozart Bassoon Concerto or equivalent concert piece.
- French Horn: (1) Chromatic scale from petal C to high C above the staff mm=144 for quarter note. 2 octave C major and C natural minor scales both to high octave above staff mm=80 for quarter note.
  - (2) A movement of a concerto for horn by Mozart or Strauss or equivalent.



# **AUDITION REQUIREMENTS**

- Trumpet: (1) Chromatic scale from low C to High C mm=144 for quarter note. 2 octave D major and D natural minor scales mm=80 for quarter note.
  - (2) One movement of Haydn, Hummel, Telemann, Artunian or equivalent concerto. Must be fluent in all transpositions. Use of C trumpet may be required
- Trombone: (1) 2 octave chromatic from beginning on low F mm=144 for quarter note. octave C major and C Natural minor scales mm=80 for quarter note (2)One movement of Martin, Bozza, Marcello, Telemann, or equivalent concerto.
- Tuba: (1) 2 octave chromatic from beginning on low F mm=144 for quarter note. 2 octave C major and C Natural minor scales mm=80 for quarter note (2) One piece from Blazhevich 70 Studies Volume 1.

Timpani: Three minute solo for timpani. Mastery of timpani tuning.

These camps bring together participants from several countries and take place usually in summer. Camps may have themes such as sports, culture, nature, language, computer or participation in a community service project. Some camps provide leadership training and address international concerns. By bringing together international participants, camps promote cultural tolerance and international understanding through friendship.

Where possible young people with disabilities will be included in the camp or tour programs, however for the more severely disabled special camps known as **'Handicamps'** are organised where participants can be assisted by a carer. In addition to this Application Form further information from participants will be required by the organisers.

Read all directions on each page carefully **before** completing the application. Use the checklist on the last page to ensure that you have completed all sections and obtained all necessary signatures.

If you are accepted into the short term program this application will be sent to the hosting country and will serve as your introduction to the people who will organize your stay or host you.

### **Components of Your Application**

### **Completing your Application**

Your application *must* be legible. Typed or computer-generated applications are **strongly encouraged**.

Answer all questions completely and as asked (*do not* write "same," "see above," or "see page"). Enter the information into the space provided unless directed otherwise. To avoid any chance of misinterpretation take care with your grammar and spelling.

Wherever the application asks for your full legal name, enter your name **exactly as it appears on your passport or birth certificate.** On pages that have a box in the upper right-hand corner marked "Applicant Name", enter the preferred form of your name. For example, an applicant whose full legal name is Joseph David Smith might enter *Joseph Smith* or *Joe Smith*.

#### Printing Your Application and Signing the Forms

Submit four complete sets of this application. (You may also wish to make an additional set for your own records.) Sets 2-4 can be good quality photocopies. On all copies the signatures must be ORIGINAL and in BLUE. To achieve this:

Short-Term Exchange Program Rules and Conditions of Exchange, Permissions and Declarations

As a Youth Exchange Program participant supported by a Rotary club or district, you must agree to the following rules and conditions of exchange. Violation of any of these rules may result in dismissal from the program and immediate return home, at your expense. Please note that districts may edit this document or insert additional rules if needed to account for local conditions.

### **Rules and Conditions of Exchange**

- You must obey the laws of the host country. If found guilty of violating any law, you can expect no assistance from your sponsors or native country. You must return home at your own expense as soon as released by authorities.
- 2) You will be under the host district's authority while you are an exchange program participant and must abide by the rules and conditions of exchange provided by the host district. Parents or legal guardians must not authorize any extra activities directly to you. Any relatives you may have in the host country will have no authority over you while you are in the program.
- 3) You are not allowed to possess or use illegal drugs. Medicine prescribed to you by a physician is allowed.
- 4) The illegal drinking of alcoholic beverages is expressly forbidden. Students who are of legal age should refrain. If your host family offers you an alcoholic drink, it is permissible to accept it under their supervision in the home.
- You may not operate a motorized vehicle, including but not limited to cars, trucks, motorcycles, aircraft, allterrain vehicles, snowmobiles, boats, and other watercraft, or participate in driver education programs.
- 6) You must have travel insurance that provides coverage for accidental injury and illness, third party liability, death benefits (including repatriation of remains), disability/ dismemberment benefits, emergency medical evacuation, emergency visitation expenses, 24-hour emergency assistance services, and legal services, in amounts satisfactory to the host Rotary club or district, with coverage from the time of your departure from your home country until your return.

- 7) You must purchase return travel ticket before departure from the home country.
- 8) You must attend all orientations and trainings offered by the sending and host districts and clubs.
- 9) You must have sufficient financial support to assure your well-being during your exchange. Your host district may require a contingency fund for emergency situations. Unused funds will be returned to you or to your parents or legal guardians at the end of your exchange.
- 10) You must follow the travel rules of your host district. Travel is permitted with host parents or for Rotary club or district functions authorized by the host Rotary club or district with proper adult chaperones. The host district and club, host family and if you are under 18, your parents or legal guardians must approve any other travel in writing, thus exempting Rotary of responsibility and liability.
- 11) You must return home directly by a route mutually agreeable to your host district and, if under 18, your parents or legal guardians.
- 12) Any costs related to an early return home or any other unusual costs (language tutoring, tours, etc.) are the responsibility of you and your parents or legal guardians.
- 13) You should communicate with your host family, if applicable, prior to leaving your home country. The family's information must be provided to you by your host club or district prior to your departure.
- 14) Visits by your parents or legal guardians, siblings, or friends while you are on exchange are strongly discouraged. Such visits may only take place with the consent of the host club and district and within their guidelines.
- 15) Talk with your host counselor or other trusted adult if you encounter any form of abuse or harassment.

### **Recommendations for a Successful Exchange**

- Smoking is discouraged. If you state in your application that you do not smoke, you will be held to that position throughout your exchange.
- If placed in a host family, respect your host's wishes. Become an integral part of the family, assuming duties and responsibilities normal for a person of your age or for children in the family.
- 3) Make an effort to learn the basics of the language of the host country.
- Attend Rotary-sponsored events and, if living with a family, host family events, and show an interest in these activities. Volunteer to be involved - do not wait to be asked.
- 5) Avoid serious romantic activity. Abstain from sexual activity.
- 6) Do not borrow money. Pay any bills promptly. Ask permission to use the phone or computer, keep track of all calls and time on the Internet, and reimburse the costs you incur.
- 7) Limit your use of the Internet and mobile phones. Excessive or inappropriate use is not acceptable.
- If you are offered an opportunity to go on a trip or attend an event, make sure you understand any costs you must pay and your respons ibilities before you go.
